A benefit provided vendors by Mansfield Restoration is access to the Mansfield Bridge Food Court to all customers of our vendors. The Mansfield Bridge Artisans and Food Court is kept clean by our attendants and maintained in a timely and safe manner. The Small Festivals begin with the Mansfield Maple Syrup Festivities in February and end with the Mansfield Old Time Christmas in November and December. The small festivals are increasing in size each year and the number of activities associated with the Mansfield Small Festivals are also increasing each year. Your participation will help the Mansfield Small Festivals continue to grow and prosper.

**Agreement: A 100% payment is required at approval of application to reserve your space for 2005. No refunds are available for the Mansfield Small Festivals.**

I the undersigned, along with any of my representatives or agents, agree to hold the Mansfield Restoration, LLC and any of its associates or successors as harmless and free from any liability in the event of any unforeseen occurrence such as loss or damage of work, loss of income, personal injury including death, or property damage arising from the rental or occupation of space for the Small Festival. I further agree I have read this document, and the attached rules and regulations and agree to abide by them. Arts & Food Court vendors will supply White Tent with sides. A Certificate of Insurance must be mailed directly to Mansfield Restoration LLC at least one month in advance of the 2004 Small Festival. There are no exceptions to this requirement. Lessee will not be permitted to set up booth space until the Certificate of Insurance is received. No exceptions will be made to this requirement

All spaces are leased on a monthly basis for the month of the Small Festival. Failure to setup at the Small Festival will cause the vendor to forfeit their space WITHOUT REFUND.

The lessee understands that a number of variables will affect their success and number of sales during the Small Festival These variables include but are not limited to: your product and its presentation; customer demand; weather; size of crowd; local, state and national economy; political climate; location on property; traffic pattern; and most importantly, buying behavior of the visitors to the Festival. Mansfield Restoration LLC in no way implies or guarantees that you will be successful. The Small Festival is a very competitive event for vendors and for this reason Mansfield Restoration LLC will attempt to make the Food Court an attractive location for you to conduct your business but in no way does Mansfield Restoration LLC assume any liability for your level of success. In signing this agreement you are agreeing to hold Mansfield Restoration harmless for any losses you may incur during the Covered Bridge Festival and by signing this document it is further understood that there will be no refunds for lessee for lease fees paid to conduct your business during the 2005 Small Festival.
